Operating Financial Commentary for the Month of April 2023

Club Operating Statement Review For the month of April 2023

Total revenue was \$38,400 (3 percent) favorable to the budget of \$1,241,100. April was a great month for the golf program. Green fees totaled \$145,500, favorable to budget by \$10,400 (8 percent). All other golf-related revenue categories such as merchandise sales, driving range income, golf cart rentals and golf lessons combined for a positive budget variance of \$12,600 (41 percent). Other notable favorable revenue categories were billable services (offset in expenses), guest room rentals, interest income, and other income in the Community Activities Department (e.g., AV services, facility setup and use fees). The most significant unfavorable to budget revenue category was bar sales with a negative budget variance of \$5,400 (10 percent). Resident activities income and lessons/classes were also unfavorable for the month with a combined negative budget variance of \$5,800 (41 percent), offset with lower expenses.

Total expenses were \$700 favorable to budget, or .06 percent less than the budget of \$1,148,200. The most significant favorable to budget expense category was water expense with a positive variance of \$46,700, or 72 percent (actual \$18,000 vs. budget of \$64,700). Other notable favorable to budget expense categories for the month were as follows: 1) irrigation supplies (actual \$800 vs. budget of \$7,200), 2) Comcast expense (actual \$84,100 vs. budget of \$92,400) due to new contract less than budget, and 3) planting expenses (actual \$1,100 vs. budget of \$7,700). Highlights of unfavorable to budget expense categories were the following: 1) tree trimming (actual \$25,100 vs. budget of \$8,700) due to timing on the golf course, 2) employee expenses (actual \$756,500 vs. budget of \$737,600), 3) gas/electricity expenses (actual \$45,000 vs. budget of \$29,700) at the Clubhouse, pools and community centers, 4) Board of Director's expenses (actual \$7,000 vs. budget of \$400) for Volunteer Recognition Event, and 5) advertising/promotion (actual \$9,000 vs. budget of \$2,600) for Bistro BOGO promotion and Easter buffet decorations.

The net positive operating budget variance for the month of April was \$39,100. See table below.

Club Board President's Message—May 30, 2023

Hello, Villagers! The month of May has nearly come and gone since I've last had the opportunity to communicate with you. I hope you've each enjoyed the lovely weather this month and were able to celebrate a meaningful Memorial Day weekend. On Memorial Day, The Villages Veterans Club and their leader, Bob Semple, hosted a lovely service and tribute to those who have both served and fallen while protecting the United States of America as a member of our armed forces. I attended this meaningful and thoughtful event and was gratified to see the Cribari Auditorium nearly filled, including many Villagers proudly wearing their service uniforms. Thank you to Mr. Semple and the Villages Veterans Club.

On a more sobering note, on May 16, 2023, I received an email from Director, Garry Ashby, with his letter of resignation from the Club Board of Directors. I want to personally thank Garry for his service to The Villages. Over at least the past dozen years, Garry Ashby has given generously of his time and energy to make The Villages an attractive choice to live and thrive for active seniors in Northern California. Garry has provided leadership through his participation in the Club Board, the Association Board, Verano DAC, EPC, and many other Villages organizations. We've all benefitted from Garry's many years of industry experience which he has generously shared with The Villages, and we've all certainly enjoyed Garry's inimitable wry sense of humor. I will particularly miss Garry's wonderful smile and quick wit. Garry's participation in the governance of The Villages will be missed by many. We hope he fills his newly found free time with more golf and other fun activities. I understand he's already joined the Board of the Villages Veteran's Club. On behalf of the entire Club Board of Directors of The Villages Golf & Country Club, thank you, Garry Ashby!

As for what's next for the Club Board, allow me to make several things clear about the legal process that will be followed to handle replacing the Director position vacated by Garry Ashby:

1. There is now officially a vacancy on the Club Board of Directors for The Villages Golf & Country Club. The Club Board is maintaining quorum with 6 (six) remaining Directors to complete FY23. The Club Board will not immediately seek to fill the vacancy that has just occurred so near the end of FY23.

2. The current FY24 election process to select two new Club Board Directors from the pool of three candidates will continue course, no change in direction or meaning—no new messaging. Two new Directors will be elected via the standard process that is currently underway and will seat on the Club Board. The Club Board will have a vacant Board Director position as it enters FY24, maintaining quorum with 6 (six) Directors.

3. The Club Board will continue with its current plans to hold the Annual Meeting of the Members of The Villages Golf & Country Club on Wednesday, June 14, 2023, at 5 p.m. in the Fairway Room of the Clubhouse. Results of the FY24 election will be announced at that meeting, naming two new Club Board Directors.

4. At any time, the Club Board may appoint a replacement Director to the vacant position who may serve the remainder of the FY24 term until the FY25

The ABOD is Proposing Changes to the CC&Rs to Benefit Members

Villager Article Five (of Five articles)

This is the final article in the series of five Villager articles describing the highlights of the proposed Amendment to the Association's CC&Rs. A quick recap:

First article - This article discusses a group of changes focused on making it easier for members to gain approval for changes to Common Areas around their homes, ensure a healthy Architectural Committee staffing level, and to update the rules on Solar Energy Systems.

Second article - This article discusses changes to the descriptions of the liability and the property insurance coverage that the Association purchases each year. The Association already purchased policies that meet these descriptions, and the change is meant to formally document these coverages.

Third article - This article discusses two changes to address the impact of inflation on the section of the CC&Rs that describe what happens in the case of a disaster (like a devastating earthquake or fire) and the Association does not have sufficient insurance coverage to cover the loss. Since the time these Sections were last approved, the cost of repairs or replacements have greatly increased. This means that the amount of money that determines whether the deficiency is "minor" or "major" needs to be increased to match current costs.

Fourth article - This article discusses five changes that help clarify what items are included in your home that are your responsibility to maintain and which ones are the Association's responsibility. The proposed new wording does not change any of the current responsibilities, only improves clarity.

Is the Amendment going to increase my HOA fees?

It is not intended nor anticipated that the CC&R amendment will cause any change to your HOA Fees. There are legal costs to prepare the CC&R amendment itself and the ballot, as well as to hold an election, but these are not enough to materially increase HOA fees.

How do I vote?

Fill out the ballot sent to you (one per unit) and return it by U.S. Mail or by dropping off in the Drop Box in the parking lot across from the entrance to Building A.

How much time do I have to vote?

Ballots are being distributed beginning Friday, June 9 and should be returned as soon as possible. To encourage early voting incentives are being offered! The initial voting period is until July 24, but the Association Board can extend the deadline if needed. If you don't receive a ballot or misplace yours, please contact Julia Meadows at: 408-223-4634, or at: jmeadows@the-villages.com.

Incentives for Voting Quickly - If you return your ballot before the end of the day on June 26, you will be entered into a random drawing for one of twenty \$50 Villages gift cards. If you return your ballot between June 26 and the end of the day July 10 you will be entered into a random drawing for one of twenty \$25 Villages gift cards.

Why does the title of the CC&Rs include "Power of Attorney"?

The amendment to the CC&Rs makes no change to power of attorney. The words, "Power of Attorney," are simply part of the title of the basic CC&R document. The full name of the basic CC&R document is the following: "Amended and Restated Declaration of Covenants, Conditions and Restrictions and Power of Attorney of The Villages Association." Every one of us, when buying or renting a villa in The Villages, signs a document accepting the Association and the CC&Rs as legal governing entities of The Villages Association. The basic CC&R documents contain a paragraph granting the Association power of attorney to the extent necessary to carry out and enforce the provisions of the CC&Rs.

Year-to-date (ten months), revenue is \$45,000 unfavorable to budget, 0.4 percent less than the budget of \$11,566,000. Year-to-date, expenses are \$483,000 favorable to budget, 4 percent less than the budget of \$11,546,000. **The year-to-date net positive operating budget variance is \$438,000.** See table below for results by department. The monthly solar lease payments and contribution to the balloon payment fund (to be paid in September 2023) are being funded from a portion of the FY22 Operating surplus. The year-to-date total for these two items is \$212,000.

All Other shows a \$208,000 net positive variance due to favorable water expenses, Comcast expenses, irrigation supplies and planting expenses. Community Activities has an \$84,000 net positive variance mostly from favorable employee expenses, printing expenses and advertising income. Clubhouse/Restaurant shows an \$81,000 net positive variance due to favorable food sales and employee expenses, offset by higher food costs, promotion expenses, credit card processing fees, and gas/electricity expenses. G&A has posted a \$49,000 net positive variance due to favorable employee expenses and legal fees, offset by higher professional fees (prior HR consultant). Public Safety posted a \$38,000 net positive variance due to less than planned employee expenses. Golf Course/Pro Shop shows a \$24,000 net positive variance from favorable water and employee expenses, offset by unfavorable green fee revenue. Pools have a \$26,000 net negative variance from higher than planned repair and maintenance, gas, and

electricity expenses. Community centers show a \$21,000 net negative variance from higher than planned electricity, repair & maintenance and insurance expenses, offset by more than planned rental income and lower water expenses.

Association Operating Statement Review

For the month of April 2023

Revenue was \$100 (0.01 percent) unfavorable to the budget of \$1,014,200 due to less than planned laundry concession fees, offset by more than planned third party assessments.

Expenses for the month were \$73,300 (7 percent) favorable to the budget of \$984,800.

Notable favorable to budget expense categories for the month were the following:

- Water Expense, \$92,100 (54 percent) less than budget (actual \$78,500 vs. budget of \$170,600)
 - Results from two-month water bill for March/April
 - Irrigation water usage continues with restrictions of two days per week
- Planting Expense, \$17,200 (88 percent) less than budget (actual \$2,400 vs. budget of \$19,600)
- Irrigation Maintenance, \$16,500 (41 percent) less than budget (actual \$24,200 vs. budget of \$40,700)

Significant unfavorable to budget expense categories for the month were the following:

- Insurance Expense, \$38,200 (15 percent) more than budget (actual \$292,400 vs. budget of \$254,200) due to impact of 2022 property insurance renewal effective May 30, 2022, and March 2023 renewals for all other lines of insurance coverage
- Electricity Expense, \$7,300 (100 percent) more than budget (actual \$14,600 vs. budget of \$7,300) due to timing of California Climate credits from PG&E (received last month)
- Pest Control, \$4,300 (49 percent) more than budget (actual \$13,200 vs. budget of \$8,900)

The net positive operating budget variance for the month of April was \$73,200. See table below.

Year-to-date (ten months of operations), total revenue is \$10,142,100 or \$100 more than the budget of \$10,142,000. Year-to-date, operating expenses are \$9,823,400, or 3 percent (\$299,900) less than the budget of \$10,123,300. The positive budget variance is attributed to savings in water and planting expenses, offset by more than planned insurance expenses, pest control expenses and operating supplies. **The year-to-date net positive operating budget variance is \$300,000.**



While there I developed, built, and operated nuclear, gas-fired, and solar powerplants. I continue consulting to power and industrial clients on renewable energy storage projects and renewable power development. I was President of Gilroy's Economic Development Corporation and served 24 years in the Navy retiring as Captain USNR-R.

Question 4: Given that there will be increases in some costs in the coming years, how do you recommend managing our assessments?

Howie Blumstein

First. I am concerned that the Club Board is considering to revise the current investment policy in favor of a new investment program that might increase investments, but introduce significant risk to funds collected on our behalf intended for reserves.

Funds are safely invested by senior staff in accordance with Club Fiscal Policy CPo 305 Investment Policy. This policy states that US Government Securities (Treasury Bills, Notes and Bonds) and CDs insured by the FDIC are the only Authorized Investments.

The investment program being considered states the Directors will commit to an Investment Consultant, to invest "... in a portfolio including common stocks, bonds, cash equivalents, and alternative investments". These investment vehicles are subject to the whims of the stock market.

The Directors have the fiduciary responsibility to safeguard Villages assets. If there are significant losses, increased monthly assessments for reserves or a special assessment to replenish the losses could be necessary.

Second. In addition to Assessments three additional revenue sources for the Club are Golf, the Restaurant/Bistro and investment income. Currently Treasury Bills, Notes, Bonds and CDs are returning \$475,000 annually.

In the current environment Government Securities and CDs are offering exceptionally high, guaranteed returns. All three revenue streams should be reviewed to achieve improved results

And of course the Club Board has the responsibility to manage expenses and procedures to maintain/lower all cost items.

I will work closely with the Directors and Residents to achieve improved results for The Villages.

Understandably, there is ongoing concern about managing resident assessments. It's clear that costs have been ratcheting up in our daily lives; the same is true for The Villages. Landscape costs, insurance, water and electricity, for example, are on the upswing. Concurrently, our purchasing power has been squeezed by inflation. We have no choice but to respect this reality, but we are not powerless to control our financial future.

- I pledge to work with all parties involved in Villages expenditures to keep assessments as low as possible as we balance the demands of maintaining our quality of life and our fiscal well-being.
- I support completing the implementation of our new financial and operations software system to enhance controls.
- I also encourage adopting a different budgeting method, currently being considered, called zero-based budgeting, that differs from traditional budgeting by ex-aming all expenses for each new period, instead of making incremental changes to prior-year budgets. It starts from a budget of zero, forcing managers to scrutinize all spending and requiring them to justify every expense item.

My experience as the mayor of Grover Beach required the same kind of challenges on behalf of the city. My experience as the founder/operator of a successful small business afforded me even more personal and practical knowledge in fiscal responsibility.

Recently our assessments have been based on aggressive reserve spending forecasts and appropriate staffing plans. We have not been able to thoughtfully spend on the reserve plan nor fill the budgeted staff positions. This resulted in operating and reserve funds surpluses. The capital fund has been underfunded and no moneys exist for refurbishment or installation of any new capital projects.

The surplus makes our financial condition appear favorable. The reality is that the inflation of 2022 and 2023 has reduced the purchasing power of our cash and investment funds. The increased costs of operations require increased assessments to meet budgeted expenses. Major contributors include labor, contracts for landscaping and golf course, electricity, and water costs.

The Board and General Manager have identified initiatives for FY24 to improve financial management and reduce costs through better procurement practices and operational efficiencies. These include:

- A new investment policy to maintain purchasing power,
- A new financial and operations software system (ERP) and
- Zero-based budgeting for next year.

As Club Board Treasurer I will work with the Board and General Manager to keep assessments as low as possible, as we address the challenges of maintaining financial health and the quality of life at The Villages.

So why am I here, running for the association board?

Therefore, I will work closely with internal Villages groups, staff, and local and state agencies to continue to improve and carry out our existing programs.

Overall, I am a qualified and dedicated public servant that understands the critical importance of equipoise in local governance. If elected, I will work tirelessly to promote the common good and ensure that our community thrives for years to come.

Question 4: Given that there will be increases in some costs in the coming years, how do you recommend we manage these increases?

Stephen Gilbert

Many of our costs are fixed, but some can be manipulated.

About 75 percent of our water goes to landscaping, and water costs have increased greatly over the past few years. The board has authorized hiring an expert to develop a long-term landscaping plan for The Villages that is attractive, fire safe, and drought-tolerant. Every time we take out a section of grass and put in drought-tolerant shrubs, we save on water and landscape maintenance costs. Little changes will add up.

Much of our insurance coverage is mandated by our CC&Rs and state law. However, we can make some adjustments. Some have proposed that we self-insure. Unfortunately, that will violate state law in many cases. However, increasing deductibles, where permitted, could have the same effect as self-insurance, and would lower our insurance costs. Reducing our fire risk will also help bring down costs.

There are several smaller budgetary categories that could net savings. For example, modernizing lighting could net long-term savings. Also, we used to paint on a schedule. We've extended that schedule recently by assessing paint conditions, and painting only where conditions require it. We can apply that approach to roads, concrete, and other repairs.

Michael Schwerin

The reality of our assessments is that for the coming 2023/2024 budget:

- Landscaping and related expenses are just over \$3.6 million;
- Water expense is just over \$3 million; and
- Insurance is just over \$4 million.

The above totals \$10.6 million from a budget of \$13.7 million; that is 77 percent of the total budget. With payments to the Club Board for additional landscaping costs and employee expenses of almost \$1.7 million, it is obvious which areas need to be managed most. This past year the board began making attempts to address all three areas. Altering our landscaping to drought tolerant plants, turf reduction and hardscaping will save landscaping costs because there will be less work for the landscapers and will reduce their bill. This will also reduce water usage and thus, water expense. And by hiring an expert to lower the risk of wildfire to The Villages, the fire safety committee has taken the first step in reducing insurance costs. The reality of the insurance market is that it is cyclical. Premiums rise and fall depending on the claims made throughout the state. With large payouts due to wildfires in the recent past, insurance companies have raised premiums to offset those costs. I would hope that as wildfires decrease, so will insurance rates. But we must also look to other avenues to try and reduce this expense.

Shannon Bergman

In considering how to handle assessments, I think it's important to start with the end in mind. Whatever we choose to do or not do, the Board must act so we 1) maintain and increase the value of our homes 2) manage our money and timing of projects so that special assessments are not necessary and 3) keep monthly assessments as low as possible.

Also, there are obvious things that can be done. For example, putting all non-urgent projects above a certain amount of money out for competitive bidding is effective. Regarding landscaping, splitting the Villages into zones that are small enough to attract multiple bidders and thus encourage competitive pricing and quality workmanship will also help drive down costs.

I think, at present, the Boards have done a good job managing budgets. However, I believe that with what faces us – costs to change to drought-friendly landscaping, tightening fire mitigation standards, state mandatory labor cost increases, increased electricity costs, increased insurance costs, more damages due to increased rainfall – that a deeper level of scrutiny and strategy of how and especially when we spend our money is necessary. We can always do better.

Help Us Keep Your Vote a Secret

Do you wonder if your vote is really a secret? If so, you're not alone. Some Villagers do not fully understand our two-envelope secret ballot system, so here are some answers.

Three Election Inspectors, Jeanne Filice, Kathy Weatherford and Janelle Marines have been appointed by The Villages Association, Homeowners and Club Boards of Directors.

Once your ballot is placed in a locked ballot box, it is kept under lock-and-key at all times.

The Inspectors remove and sort the ballot envelopes according to color (blue for Association, green for Homeowners, and ivory for Club).

The bar codes are scanned, which registers and validates that the envelope was received from a member who is eligible to vote. The bar code must remain intact for the ballot to be valid.

Following registration, the barcoded envelope is opened and the secret envelope is removed. Barcoded envelopes are sent to storage while secret envelopes are bundled for counting.

On counting day, only the secret envelopes are given to the Tellers for counting. These envelopes contain no names, bar codes or other identifying marks. They remain sealed and under lock-and-key until the Inspectors and Tellers meet at an open Board of Directors meeting to begin the counting process.

This entire process is in accordance with California Civil Code.

The counting process is closely directed and monitored by the Election Inspectors. All ballots are counted by two different Teller teams to ensure accuracy.

The Inspectors present the election results to the Boards of Directors at the annual membership meeting on June 14. Mark your calendar now and plan to attend!

Villagers can rest assured that the Election Inspectors follow Civil Code and the election rules for every election so your vote remains a secret. You can help us keep your vote valid and a secret by carefully following the instructions included with your ballot package.

If you have further questions or if you'd like to witness the entire process, please contact one of the Election Inspectors. And please...cast your vote before the deadline!

Recommend managing our assessments?

In recent years, the Association has faced various challenges that have led to an increase in costs. These challenges include inflation, market forces post-covid, and climate change.

However, we can still control costs in many areas. For instance, water usage makes up approximately 20% of our expenses, and although we can't control the cost of water or meter fees charged by the water district, we can manage the amount of water we use through drought-resistant landscape planning and implementation. Insurance costs have also been rising, but we can minimize the rate of increase by practicing preventive maintenance to lower claims and implementing the new fire prevention program which will reduce our risk of wildfire damage. Additionally, negotiating with our suppliers and using cost-effective products and services in our future projects is crucial for long-term cost control. We are fortunate that we have an experienced staff and third-party consultants that will assist in assuring that our reserve contributions are appropriate for our future needs.

As Verano DAC chair, I have experience in focusing on our expense performance and look forward to collaborating with residents and fellow directors to tackle these challenges head-on.

The ABOD and DACs should embrace a mindset of questioning many things that have been done the same way for years at The Villages.

Current members have been making efforts to hold down monthly fees, but I would like to see a broad-based, publicized campaign.

We should examine the premises behind major assessments – For example, are we really on the correct schedule for replacing roofs and for painting? Can we break up some major contracts into smaller pieces and get more competitive bids?

New accounting/business management software will allow us to adopt zero-based budgeting, meaning that every major assumption about large expenditures can be questioned and justified.

I would like to see this be a real movement in The Villages, with marketing and communication to inform us of ideas and results. Many ideas may not work, but that's okay because some will, and at least residents will feel like they are trying to have a positive impact on the bottom line, instead of feeling helpless.

Update: 2023 Annual Member Meetings and Elections

The three Villages Corporations (Club, Association and Homeowners' Corporation) are preparing for this year's elections and annual membership meetings.

Elections will be conducted in May and June with election results announced at this year's annual membership meetings to be held on Wednesday, June 14, 2023, with the Homeowners' Corporation to be at 3 p.m., the Association's at 4 p.m. and the Club's at 5 p.m. (Unlike during the pandemic when they were held via Zoom, this year the annual meetings will be held at The Villages Clubhouse.)

Club: The election will be held for two director positions (each for a term of three years) on The Villages Golf and Country Club (VGCC) Board of Directors. The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. The directors who will continue to serve during the ensuing year are Leslie Lambert, Judy Owen, Bob Krattli, and Liz Kung. Directors with terms expiring are Bob Wilk and Richard Zahner.

There are three candidates for which nominations have been qualified for the ballot, Howie Blumstein, Larry Versaw, and Richard Zahner. Pursuant to the Club Bylaws, the two candidates receiving the largest number of votes shall be elected to serve a term of three years.

Association: For the Association, in addition to the vote The Villages Association Resolution, Excess of Membership Income Over Membership Expenses Refunded to Members, election will be held for four director vacancies, two vacancies for terms of three years and two vacancies for terms of two years.

The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are David Cook, Diana Hallock, and Julie Wash. Director terms expiring are that of Richard Holmboe, Stephen Gilbert, George Paris, and Michael Schwerin. As of the duly noticed Deadline of Nominations date of March 28, 2023, and as duly noticed per California Civil Code and The Villages Association Rule 2.25 Voting and Elections Rules, Michael Schwerin, Stephen Gilbert, Patricia Reardon, John Epperheimer, and Shannon Bergman are the candidates for this year's director election.

Per the Association's bylaws, the persons (four) receiving the largest number of votes shall be elected and, of those elected, the two receiving the largest number of votes shall be elected to fill the terms of three years, and the persons receiving the third and fourth largest number of votes shall be elected to fill the terms of two years. (In the case of a tie, a run-off election will be conducted.)

Homeowners: The Villages Homeowners' Corporation will conduct a vote on The Homeowners' Corporation Resolution, Excess of Membership Income Over Membership Expenses Refunded to Members and election to fill one director vacancy for a term of three years.

The bylaws of the Homeowners' Corporation provide that there will be five directors. Those who will continue to serve during the ensuing year are Teddy Morse, Jeannie Omel, Brooks Fuller, and Larry Versaw. As of the deadline of May 1, 2023, at 5:00 p.m. there has been one candidate nominated and qualified, Rob Kirschbaum, and per Section 7.3 of the bylaws of The Homeowners' Corporation is declared elected by acclamation and will begin his term as Director on June 14, 2023, upon adjournment of the Annual Meeting.

Deadline to return ballots is Monday, June 12, 2023, at 8 a.m.


Filmed at both Tate Modern and MoMA, the film reflects the preparation and exhibition of Matisse's simple but sophisticated cut-outs. Along with the

'Feast of the Most Holy Trinity'

Sunday is the feast of the Most Holy Trinity. The Trinity is the mystery of all mysteries, the very root of the Church's living faith. What is the Trinity? Jesus revealed this heretofore unknown "mystery" (i.e., a truth we cannot fully understand) especially in John's Gospel. What He revealed was that in the one God there are three distinct (really different) persons: the Father, the Son, and the Holy Spirit. Each one is God almighty, which is why we call each of them "divine." Yet they are not three Gods. None is greater or older than the other. The three Divine Persons are one and the same God. To our limited intelligence this revelation, this supernatural truth is a conundrum, a paradoxical, insoluble, or difficult problem. The church summed up this enigmatic teaching in one word - "Trinity" (which itself does not appear in Scripture).

The Trinity is what Catholics call a "mystery." Human intelligence cannot grasp it by way of the senses and natural human reason, however brilliant, educated, genetically enhanced, technologically assisted or influenced by mind-expanding drugs the individual or collective human intellect might be. Reason and the senses, being aimed at understanding the material world, have limits. Breaking through those limits, getting outside the box of finite materiality, requires a "second set of eyes", the eyes of faith.

Faith is a gift God gives at Baptism to equip a person to know, albeit in an indistinct incomplete way, eternal realities only God Himself can reveal, marvels that surpass all natural ways of human knowing. Faith enables one to believe such disclosures are true because Jesus revealed them and Jesus is God. Faith opens, even to mere children, realms of otherwise imperceptible truths like the Trinity that are inaccessible to reason alone. We recall such revelations every time we recite the Creed at Mass.

For Catholics, no antagonism exists between reason and faith. They are two complementary ways of knowing directed at two different realities - reason to the finite, natural, material world and faith to the infinite, supernatural, spiritual one. Reason is intrinsic to being human, while Faith is a gift from God that comes only through Baptism. Reason without faith is partial blindness, Faith without reason is superstition.

Through faith, the baptized are even now enabled to partially grasp unseen eternal mysteries existing outside of space and time, like the Trinity, via images and reflections. Only when Jesus comes again, and they see God face-to-face, will such divine revelations come into sharp focus.

Faith was planted in us like a seed at Baptism. To become operational, it must be developed. One small step in that direction is to open the "Catechism of the Catholic Church" and review its concise summary of what the Church teaches about the mystery of one God in three persons. Read about the "Trinity" in paragraphs #249-267 and expand your faith this Sunday.

Some of the fishing spots required a rowboat to reach them. Once, her father and I crossed a large lake and when it was time to return, we struggled to keep the boat straight because of the wind. It was a little frightening and that was my last time in a rowboat on a large lake. I think it was his last time also!

I remembered the many times that he would go to the store because their mother had forgotten an item or ran out of something for a meal. When Gloria and I started dating there were nine children, with Gloria being the eldest. Their dad had a passion for hunting, fishing and gardening, which was an opportunity for him to have some alone time. When he returned from his trips or the garden it was all hands on deck to clean and preserve the food. He would also order half of a Black Angus for their freezer to have throughout the year.

He really impressed me as a father who loved God, his family and the simple things in life. He would load up the family in their Woody Ford Station Wagon for church on Sunday mornings and then after service he would pick me up and take me home with them. Often I would stay for dinner. Gloria's mother had many talents; I relished her wonderful cooking. Her father made room for me in his heart and their station wagon. I admired him and wanted to be like him, with only two exceptions: 10 kids and going to the store multiple times in a day every week.

When I became a Christian, one scripture that I memorized, because of the way Gloria's father lived his life, was Psalms 1:1-3NIV 1 *Blessed is the one who does not walk in step with the wicked or stand in the way that sinners take or sit in the company of mockers, but whose delight is in the law of the Lord, 2 but whose delight is in the Lord, and who mediates on his law day and night. 3 that person is like a tree planted by streams of living water, which yields its fruit in season and whose leaf shall not wither- whatever they do prospers.*

When you leave your mark, how do you want others to remember your life? Will it be one of integrity?

Trinity Sunday

Trinity Sunday, this very Sunday, is the great feast of the church that our Cathedral is named for. It is also one of the more confusing doctrines of Christianity. One God in three persons, indivisible and yet distinct, is difficult math at best. Why bother with such an inscrutable image of God, in these secular times?

Confessing that I have gratefully served three churches named for the Holy Trinity, I've had opportunity to deeply ponder the triune nature of God as the Christian tradition understands it. Worshipping one God binds us together as one people, but the threefold "persons" of one God (Father, Son and Holy Spirit) means that diversity is welcome within unity. What unifies the three in one, our theologians assure us, is a relationship of love.

The nascent community of Jesus-followers in the first century came to this understanding of God because that was how they experienced God's self-disclosure. And it's also how they understood themselves, reflecting God's nature in their own lives and community. The theologians of the Trinity used a Greek philosophical term, perichoresis, to describe the loving relationship of the three persons of God. It means some very technical philosophical things about "mutual indwelling" which are worth pondering. But it also means, very literally, a circular dance. And what could be a better image of God than a dance of love and joy, that invites us all to enter into the divine rhythm?

Please join us this Sunday at 9 a.m. at Montgomery Center to celebrate both Trinity Sunday and the last day of The Rev. Nancy Ross as she leaves our Villages congregation and prepares to start a new ministry in Palo Alto.

Hole #8 Turf Reduction Project—At this time the Turf Reduction Beta Site on Hole #8 tee has been completed. The new plant material has been planted and the mulch has been spread. Now we will have to lightly irrigate the plant material until it reaches maturity and we will have to spray for some encroaching Bermuda Grass. The Beta Site looks fantastic and will even get better when the plant material has grown to full size and maturity. Cart Fairway Entrance and Exit—The 90-Degree Rule is Always an Option When Entering the Fairway

For those golfers who enter the fairway early, just after the tee box, we stress that you should please use the Cart Enter Gates located at the start of each fairway. Then proceed down the fairway from shot to shot avoiding driving in the rough as much as possible. For those who hit it longer off the tee and who do not enter the fairway early, remember that it is always okay to use the cart path until you are parallel with your ball, and then enter the fairway using the 90-degree rule staying on the cart path until you reach your drive. Then proceed down the fairway from shot to shot avoiding driving in the rough as much as possible. At the green, please remember to not drive your cart past the 30-foot Yellow Lines in front of each green, and to never drive inside the perimeter of the greenside bunkers or on the greenside slopes. When exiting the hole, please use the Exit Gates located at the end of each hole and stay on the cart path until you reach the next tee box. Let us know if you have any questions. They *all* finish on their right toe in perfect balance. There is no hanging back on their heels or reverse tilting. There is a full commitment to the target with both the lower body and the delivery of the club. And it is done at their tempo, which allows for body harmonization with the club and the resultant perfect balance. So if you feel yourself rocking backward or flat footed or off balance, look at these images and try to emulate their finish positions. I guarantee you will make better contact...weight on left leg, up on right toe, body facing the target.

PICKLEBALL

You say you want to try Pickleball? Not surprising given it's the fastest growing sport in the country. Pickleball is great fun, but there are a few things you need to know before you start playing at The Villages. To get started, you need non-marking "Court Shoes," commonly called Tennis Shoes. Court Shoes prevent marks on the court and more importantly, provide the proper support. Incorrect shoes are the #2 reason for falls and injuries. Number one is running backward; now know the two most important tips.

- Everyone (residents and guests) must register with the Club, and sign up before using the courts. You needn't be a member; you can join as a "non-member resident." To register, visit our website - villagespickleball.vgcc.club. The first post explains the process.

- Wait to buy a paddle! The Club is very sensitive to the noise factor, and a condition of our SJ Use Permit requires the use of quiet paddles and balls. Our website is a link to approved paddles. The Sun City Grand "Quiet Paddle List" is now required by many clubs and recreational facilities around the country. USAPA paddles often do not meet the requirements! The only balls allowed on the court are Onix 2 Pure balls – the PB Club buys them in bulk, and sells them at wholesale prices. The Club also has "quiet" paddles for use by our shed.

- While not required, we highly recommend a meeting with Mike Walias (mjw0275@yahoo.com). Mike gives demos on how to play Pickleball, he's the secret weapon of the club. You'll leave knowing the rules and basics. Once completed, he can recommend the best group for you to start meeting new players, plus he has paddles you can try before you buy!

- Have fun... Pickleball is a social game. Be prepared to laugh, trash talk and meet some of the friendliest people at The Villages!



Court shoes – smoother bottom with no raised "ridges" that stick to the court, facilitating lateral movement. They also have more support in the ankle area.



Running shoes – these have raised ridges and grooves, designed for forward motion. They "stick" to the ground, preventing lateral movement. Do *not* wear these!



Walking shoes – designed for stability in a forward motion, preventing any lateral movement. Do *not* wear these!



Shoes with thick or rolling soles or slip-ons – these are dangerous to play pickleball with because not only are the soles improper for a court surface, they provide no lateral support. Do *not* wear these!

Association President's Report—May 30, 2023

Welcome to the May 2023 Villages Association Board Regular Monthly Meeting, the last meeting with the current board membership.

Although the Board has been working through next year's budget for many months, many Villagers got their first look when they received their summary Disclosure statements this last week. Unfortunately, like everywhere else our costs are going up significantly. What is the Association Board doing about these increased costs? We continue to look hard at reducing our usage of water, competitive bidding, minimizing our insurance claims, reducing our exposure to wildfire risk, and considering alternative materials for big-ticket items like roofing. We have taken major steps to plan and carry out improvements in our fire safety and landscaping design to lower long-term water usage and reduce water costs. We have policies in place to carry out preventative maintenance to reduce cost of ownership, and inspections to assure that repair and replacement work is done when it is needed, not according to a rigid schedule. The Villages has added a Reserves Specialist to look deeper into our reserves planning process and funding to optimize the Association Board's Reserve Plan.

Association costs are driven by three main factors—the cost of water, the cost of landscaping, and the cost of insurance. I already mentioned new plans to reduce water use. In addition, the Landscaping contract is coming up for renewal next year and the Board will look hard at the service levels Villagers want, and tie in new landscaping designs that might reduce labor and sustainability costs. Last week, the final piece of insurance costs arrived with the renewal of our Property Insurance. The Association's share will be almost \$4M, up almost \$1M over last year, and reflects the difficulty and costs of assembling insurance coverage for a community as large as The Villages. Only a few days ago State Farm Insurance abandoned the California insurance market due to their concerns over risks due to wildfires and dramatically increased rebuilding costs. The steady progression of insurance premium increases continues and according to our brokers there is no relief anticipated in the coming year. Therefore, the Association must look more deeply into our fundamentals including governing documents about what kinds of insurance we want, what risk levels we are willing to cover ourselves, and what other sources of insurance might be available. Villages management is planning a deep dive into insurance for the Boards in July, which will create the opportunity to consider changes well before next year's insurance renewals are required.

The Villages Association will be sending out your ballot to vote on changes to the CC&Rs on June 9. Over the month of May we have published weekly articles in *The Villager* and the articles and videos are posted on the Resident Portal to help explain the changes and the purpose of each change. There will be a Town Hall meeting in Cribari Auditorium on Tuesday, June 6 at 7 p.m. (next week!) to answer any questions or concerns. As an incentive to return your ballot early, the Board will be holding random drawings for Villages gift cards. More details will follow in *The Villager* and at the Town Hall. This vote is important in and of itself, but now you have an additional incentive to return your ballot early.

Lastly, we have a vote going on right now for next year's Association Directors. If you haven't yet returned your ballot, you still have until Monday, June 12, 2023, at 8 a.m.

It has been another challenging year of lingering pandemic effects, drought, fire safety concerns, and ongoing budget pressures for the Association. I want to thank my fellow Directors for rising to meet the needs of our members, and to our Villages Management Team for their outstanding support and implementation of Board policies!

What are the CC&Rs and Why are they Important?

CC&Rs are a "Declaration of Covenants, Conditions and Restrictions" and referred to as "CC&Rs" or as a "Declaration." It is a recorded document (with the County Records Office) that contains a legal description of the Villages Association. Covenants, conditions, and restrictions (CC&Rs) describe what you can and can't do with your home. The goal of CC&Rs is to protect, preserve, and enhance property values in the community. The CC&Rs define the way in which the Association will be governed and provide for solutions in the event of certain events such as fire, earthquake, or other disaster.

When do they need to be amended?

The CC&Rs need to be amended to reflect current State Civil Code, the impact of inflation on costs, or to better reflect the current needs of members.

Who can amend the CC&Rs?

The Association Board can make minor amendments to correct typos and changes required by State Law, but only a majority of the Members can make most changes. A majority for the Villages Association means 1,155 votes must be in favor of the amendment.

You can save 10 percent a year on auto insurance

A Villager stopped by the SRS office and proudly announced that she spent \$20.01 and reduced her auto insurance premium by \$130.30 for this year and by the same amount next year. She had complained to her insurance agent because her premium had gone up substantially. She had no accidents or tickets during the past five years.

Her agent explained there were two reasons for the increase. She had reached a certain magic birthday which caused a rate increase. He compared it to a teenager premium. Also, two years ago she had taken a safe driving class and received a discount. That discount had expired, which also contributed to her premium increase.

The agent suggested she take another driving class. She remembered sitting for two four-hour sessions in the Evergreen Community Center. Four hours can seem like forever! Would it really save that much? The agent calculated the savings would be \$130.30 annually for two years.

She was still wondering whether the savings justified the effort when he suggested she could take an online safe driving course. Our Villager went to the AARP website (aarp.org) and in the search box entered "smart driver course." For \$20.01 she was registered and ready to start. If she had not been a member of AARP, the cost would have been \$29.95. Her insurance agent later suggested she look up the class at the AARP website but to not book the class immediately. He predicted she would soon receive an offer to register for the class at a discount.

She found the class to be very interactive. Short lectures were interspersed with movies, interviews, quizzes – all highly professional quality. She could start and stop at any time and go back to the class later. She couldn't really skip any part because she couldn't advance until the segment was done which required her to click at appropriate times. Because it was so interactive, she found the time went by quickly—and the content was interesting much of the time.

The Villager particularly appreciated the last segment on how to talk with your aging parents about when it is time to give up driving. The advice: 1) Ride with the driver at least several times. 2) Keep a log by date of the good and the bad. 3) Select only one family member to talk with the parents about this. 4) Research alternatives to driving. 5) Expect it to take more than one conversation. 6) When all else fails, fill out a DMV complaint

Leash rule for pets

Residents are reminded, as per Club Rule 1.51, that pets must be kept on a leash, under control, and attended to at all times. This also applies to the Hill Lands.

An increase in coyote aggression has created problems with small dogs, especially those that are unleashed. **Please always leash your pets. And keep leashes short; the Division of Wildlife recommends a leash no longer than 6 feet.**



Furthermore, accompany your leashed pet at all times while outside. Do not let go of the leash or tie your animal to trees or other objects. An unattended leash not only attracts the attention of coyotes, but is also a tripping hazard to other walkers.



"Our Missing Hearts" by Celeste Ng. 12-year-old Bird Gardner lives a quiet existence with his loving but broken father, a former linguist who now shelves books in a university library. "The House of Wolves" by James Patterson and Mike Lupica. Joe Wolf applies a cutthroat determination to his life's work, from building a California business empire to parenting three sons and a daughter. Kill or be killed. So when the patriarch takes a deadly cruise on San Francisco Bay, Joe Wolf's bloodline becomes SFPD's lifeline. Detective Ben Cantor trails the "pack of wolves" as the siblings vie for control of their legacy of power and assets. All four have the means and the motive to commit murder, but only one of them is most like Joe Wolf. Only one of them earned their father's love. Lurking in the shadows is the real alpha wolf. That creature survives on instinct. And desire. To kill all the wolves dead. Mystery, 2023.


